OFFICE MEMORANDUM

Subject: - Special Drive for Renew of YCB level-3 Certificates for applying to ICCR for Empanelment of Teachers of Indian Culture (TIC)

The Indian Council for Cultural Relations (ICCR) has invited applications from eligible candidates for empanelment of Teachers from Indian Nationals for deployment as Teachers of Indian Culture (TIC) on short-term contract basis at Indian Missions/Posts/Indian Culture Centres abroad. As per the notification, one of the essential qualifications to apply for the post is YCB Level-3 Certificate i.e. Yoga Teacher and Evaluator (Copy of the same is attached (At Annexure –I)

- 2. In this regard, requests have been received from some candidates whose certificates expired or expiring soon in near future for renewal of the same.
- 3. To consider the renew of certificates YCB is planning to conduct a Continuing Yoga Education Program (CYEP) cum surveillance/assessment through Leading Yoga Institutions, accredited by YCB on urgent basis through offline/online mode in line with guidelines of YCB for renewal of certificates (**As given at Annexure-II**).
- 4. CYEP registration fee is Rs. 2,000 which shall be paid to YCB by the candidates. YCB will pay Rs. 1,000/- per candidate to the Leading Yoga Institution(s) for conducting the said CYEP after successful conducting the CYEP and submitting assessment of candidates to YCB. LYI shall not charge any other fee/money from candidate on this account.
- 5. The Leading Yoga Institutions given in **Annexure-III** have consented to conduct 2-3 days the CYEP on or before 10th December 2023 and submit assessment result of candidates by 12th December 2023 to YCB
- 6. Professionals may register for renewal of their YCB Level- 3 certificate through following link along with registration fee.


